New Preventative Care Option

Raleigh's Endoscopy Center began participating with Blue Cross and Blue Shield of North Carolina, effective November 1, 2007, to make the cost of colonoscopies and other treatments more affordable. Patients will only be required to pay the cost of specialist office visit co-payment only. When calling BCBSNC to verify coverage, be sure to inform the representative that Raleigh Endoscopy Center participates in the BCBSNC Office Based Endoscopy program to insure that you obtain the correct information. In many cases, out of pocket expenses at the Endoscopy Center are usually less than those services provided by hospitals.
