

2020-21 Verification Worksheet



Your 2020-21 Free Application for Federal Student Aid (FAFSA) was selected by the federal processor for review in a process called verification. The law says that before providing federal student aid, we must ask you to confirm the information you and your parents reported on your FAFSA. To verify the information you provided, please complete the questions below, include parent(s) and student signatures, and mail, bring, or fax the form to the Financial Assistance Office within 2 weeks of your receipt of this letter. Failure to respond will result in our inability to disburse Federal Aid. If corrections need to be made to your FAFSA, the Financial Assistance Office will submit the changes on your behalf and will notify you of any changes by mail or email.

C. Verifying Taxable Income

You can use <u>EITHER</u> the IRS Data Retrieval Tool through your FAFSA, <u>or</u> you can submit a <u>SIGNED</u> copy of your complete <u>2018</u> federal tax return. Since the information we are requesting is from <u>2018</u>, your tax information should be readily available. (If you have not yet filed your <u>2018</u> federal tax return, please contact the Office of Financial Assistance). We have provided some helpful information below about using the IRS Data Retrieval Tool. It is easy and straightforward to use, but if you are not successful with it, please submit a <u>SIGNED</u> copy of the complete <u>2018</u> federal tax return. (It is also acceptable to submit a 2018 tax return transcript if you have already requested one from the IRS).

IRS Data Retrieval Tool:

Go to fafsa.ed.gov and indicate that you want to make a correction to your FAFSA. Navigate to the "Income" section. If you check that the tax return is already completed, the FAFSA will prompt you about using the IRS Data Retrieval Tool. You will not be able to use the Tool if:

- Your tax filing status is Married Filing Separately
- You filed a non-U.S. tax return

FAFSA will link you to the IRS web site. You will need the Social Security number of the FIRST person listed on the tax return. Follow the directions. After the tax information is transferred back to your FAFSA, **remember to hit save and submit so we will receive your new FAFSA.** (If you, the student, filed taxes, you can use the same process to verify **your** taxable income).
